Old Business review of tabled articles from 1/28/2016

1. Article for completion of hydrant installation at the intersections of Silver Lane and Harbor View Road. Lake Arrowhead Community Maintenance will supply all labor.
Motion made and seconded to have article to read same as article # 62 (2015). All in favor.

2. Article 14, Verbiage of article and agreement for Route 11 Streakers.
Selectmen propose the following:

“To see if the Town will vote to dedicate the town-owned property, Map 38 Lot____, located on the Doles Ridge Road, specifically for the site of the Route 11 Streaker’s Snowmobile Club (Limerick/Newfield) Clubhouse/Storage Facility. “

Upon passage the Board of Selectmen will work with the attorney to draft an agreement between Route 11 (Limerick/Newfield) Streaker’s Snowmobile Club and the Town of Limerick to details ~~and~~ rights and duties of both parties relative to the land and building. Second the Board of Selectmen will contact the Town of Limerick’s insurance provider to discuss insurance relate concerns and solutions.

3. Article 13 change verbiage to read as follows;
To see if the Town will vote raise and appropriate \$3,000.00 for monitoring boats **going in and out of** Sokokis Lake, State Public Boat ramp on weekends from Memorial Day to Labor Day.

 - a. Changed repair and maintenance from \$2,000.00 to \$3,290.00
 - b. Pottys are US from \$500,00 to \$720.00
 - c. New total for budget \$22,752.00

5. Revenues, total lapsed balances from 2015 was \$113,498.94.
Selectmen had \$86,000.00 for transfer from undesignated.
Committee member Thorne stated that in the past all or close to the amount be used.
Recommended that either \$100,000.00 be used and the balance could lapse into undesignated or transfer the balance to the Capital Project Reserve Account.
Selectmen voted on \$100,000.00.

Voting day is Friday, March 11, 2016 at the Limerick Municipal building. Town meeting is March 12, 2016 at the old Brick Town Hall.
